Dear Mr President

THE CIVIL COOPERATION BUREAU (CCB) RIDES AGAIN : THE FALL OF THE RSA

Mr President , we have been the victims of state organized crime. Despite our resisting all these attacks and attempts , it just does not end and carries on.

These attacks are spearheaded by Vanessa Du Toit , Director compliance at the NCACC. Arsmcor and Denel are equally on board with all these untrue allegations , on which basis warrants are obtained and which is being used to steal our goods and our business. We are slandered and the state machinery would appear extremely incompetent into attending to such.

Whatever charges we have brought with the SAPS , we find that nothing is either done or a so called refusal to prosecute is issued by the DPSA. However , at no stage are we contacted in the regard as to the investigations , we are kept in the dark as to the actual investigations. We have no faith in the standard of investigations as effected by the SAPS. However , whenever anyone says anything about us , then the SAPS moves with lightning speed. The NPA has a troika who is hell bent on finding , even creating something against us. In this regard it has been reported that Adv Shaun Abrahams , Torie Pretorius and Chris Mackintosh had at various stages said to investigating offices and generals of the military that they must find something against us. This despite the fact that Vanessa Du Toit has not spoken one true word about our situation. She appears to be the main protagonist along with Min Jeff Radebe , who has apparently unbridled presidential aspirations. He controls the NPA in a manner that suits him , also it would appear to be in a manner to cast you in a negative light. He controls the Public Protector , a fatally flawed institution . An aspect we had pointed out so many times.

Our business is being interfered with , suppliers and clients equally inform us that they had received calls from unknown persons slating us and interfering with our business relationships. Other persons were threatened by military personnel in civilian clothes that if

they would continue contact with ourselves , that their careers would be in jeopardy. So much for democracy!

The parliament is failing the country , Mr President. They are controlled by people who want to promote certain viewpoints . The question is as to who those persons are? When the Civil Cooperation Bureau (CCB) was shut down, the rest of the members thereof did not just disappear , the melted away into the reigning state structures. They were not necessarily operators , but rather people from a logistics and support background. An example is Col DBT Smit , the most senior freemason in the SANDF today. On his own version , he has been around for 16 years in his current post. His background is that of a motor mechanic but he has followed various courses , as to their applicability is another question. However , he is a typical example of a person who could and should in all probability have been in a position to render such support services to the CCB operatives.

Yet , he has stated in a sworn affidavit in court that he is under instructions to deal with our suppliers behind our back. The question therefore is as to what instructions? When we imported the East Block weapons for SA Special Forces , he was at the forefront in order to sabotage our delivery . In this regard various criminal charges had been pursued , all for naught until today. He was instrumental in slandering us on behalf of the SA Government abroad. In this regard he was ably assisted by Vanessa Du Toit , who lies under oath and yet nothing comes from our criminal charges. Why Mr President is this allowed to continue?

The Ministers of your cabinet seemed incompetent and unable to manage their departments. All our complaints are a waste of time . Shaun Abrahams has been implicated as the person who has signed in the Ghaddafi moneys into the RSA. Without authority and nothing is done. Why? It is clear that the government is being misled by these people , SA Special Forces who are supposed to be looking after your safety whilst travelling in Africa , when are they going to compromise your safety Mr President? Firstly due to a lack of equipment / serviceable equipment and /or a lack of belief in you and your cabinet. The EFF is radically altering the political scene , the Generals in the SANDF had apparently been in various meetings with the leadership of the EFF. What for Mr President?

It is very clear that the old CCB members in the state structure are on the move. They are looking at one thing , and that is money! They do not care how they compromise the state structures as long as they can benefit. The lie , they cheat , they steal. They do this in liaison with their former agents , specifically those from the Venda group. Genl Mojo Motau , an incompetent soldier along with Brig Genl Maphwanya from SASF are identified as some of the main movers in this issue. They are not alone , they are assisted by a group stemming from the SA Freemasons which are a distinctly different group as from the British freemasons.

These same people are sitting behind the slandering operations effected against us. They are in attendance in the SAPS and specifically Crime Intelligence . Our communications are monitored , they interfere in our business , the whole group have roped in their counter parts in SARS in order to raise fictitious assessments in order to steal from us . This despite the fact that Armscor owes us substantial amounts of money . The strategy is to create a fictitious assessment and then to enforce such in order to have our weapons which were legally imported declared forfeit for SASF. Armscor and Denel are two effectively bankrupt entities which survive only because they are being bailed out by the state. But they know how to steal , and exactly there , that is where the remnants of the old CCB have ensconced themselves.

The politicians and the government have no idea how they are being played and the government being defrauded. An example thereof is that Vanessa Du Toit wants writer to be arrested . For what ? For legally importing a Dillon Minigun which belongs to NGAM and which should be held in custody with SASF. However contrary to a court order , she had the Minigun stolen. Whatever she says , she had no authority to have it removed , therefore it is stolen! No SAPS station wants to accept the criminal charges in this regard! The question therefore is Mr President , what must we do?

You , Mr President are the Commander in Chief (CIC) of the SANDF. You have already lost 15 soldiers in CAR . How many more is going to be lost ? Because you had been ill advised! The Minister of Defence at least seems to comprehend that there is a problem . Her predecessor was known as a person who did not bother herself with such detail. Generals were lying to her , as they still are today. Who will be blamed for military calamities Mr President ? You will be blamed Mr President , by the public , by the politicians , by the military and meanwhile you would only have been action on advise – although bad advise which you will know about once its too late.

The courts are a shambles. The freemasons have made this their bane. One can not hope for justice in these courts. How they have slandered us without any evidence , but a witches brew concocted by these people in order to paint us blacker than black. How many other people have suffered a similar fate? How many other people have been destroyed through these actions spearheaded by the CCB remnants , the freemasons , the crime intelligence imbeciles with their stories , the stories from the heavily compromised intelligence services . In all of these instances it is interesting to note that the same persons who are de facto your enemies have been sprouting these stories. Genl Mojo Motau , Brig Genl Maphwanya , Min Jeff Radebe , Vanessa Du Toit and her husband – their relationship with Selwyn Nathan and David Hirschowitz and many more.

Many of these people claim to support the ANC , this is however not the case. They are only interested in lining pockets. Mr Ali Maziya , member in Parliament and well known to yourself , has been spreading a lot of stories about author. Maziya however neglects to recount that he had garnered moneys in working together with author on the collection of RSC levies (Act 109 of 1985) . He was sanctioned in Parliament for failing to declare his interests.

The SSA via their agents / consultants such as George Darmanovitch have been creating stories. The main aim throughout was only to steal our business , our money , our dignity. The SSA which is heavily compromised is failing the country , they are diverting resources and assets in order to ensure that they garner untold state resources for their own pockets. Interesting in this regards the freemasons are directly involved. Darmanovitsch plays many roles . He even controls the press through a company IRS which belongs to him. A certain Chad Thomas is running this company on behalf of Darmanocitsh. Through this mechanism they control the press as well as the opposition. When are they going to turn on you Mr President? They have indeed been making noises to this regard.

These are the same people that are implicated in aspects such as the Apex saga. In this saga more than 60% of the South African coal reserves have been stolen for a tippance and move off shore. They are also implicated in the disappearance of the billions of US Dollars of the Ghaddafi money.

Many allegations have been raised against the NPA . In 2010/2011 the IT company , Gijima was charged with alleged fraud to the tune of billions of rand. However , nothing came of these charges after Adv Shaun Abrahams had been involved in this matter. Currently a new set of allegations have been raised of fraud against Gijima for some R 360 million. What will

happen now? Will the charges be dropped again? What about a life style audit Mr President on these senior prosecutors from the NPA? What did these prosecutors gain? Why do they have such luxurious lifestyle? Is such lifestyles commensurate with their state salaries? What if it is not Mr President?

We have noticed that a certain Mr Willie Lötter had been caught during the 90's smuggling some 11 metric tons of gold! He was fingered as smuggling for the National Party and later on for the ANC as well. Very interesting, nothing came of his prosecution. He is deemed to be very well connected into the current government structures and is allegedly like Darmanovitch above the law and continuously busy with various nefarious actions. Is this the same principle that is in play at the NPA?

The view in various quarters are that Mr Jeff Radebe is supposed to be protecting yourself against various legal challenges. However, this would appear to be a double edged sword as the question is whether he is actually protecting you or setting you up for a fall Mr President? What is his relationship with the British MI 6, the freemasons, the London School of Economics – the recruiting centre for MI6 of foreign agents.

SARS, has been referred to. However Mr President on whose instructions do they tend to operate? All the legalese under which they claim to operate tend to be fallacies. They tend to be a tool to steal, as in our case our moneys and now by creating false assessments on moneys which we have not even received yet. We are such a threat that SARS sent 8 auditors to Armscor to delve into our affairs! SARS was a part all along of the strategy to try and destroy us. Thus the question is Mr President, what is going on in our country? SARS has become a political instrument in order to destroy anybody that stands up to protect what is rightfully theirs! There exists many examples of such illegal actions where people had been beaten into submission by the state institutions such as SARS. This is a trend which has a long history, not just of the current government.

The names referred to in this letter have been mentioned at various other occasions to yourself Mr President, however it would appear that the fury of this evil storm just keeps on growing in order to destroy us. Not only us, eventually it will devour you, yourself Mr President as well as your family and your whole clan.

Are we wasting our time Mr President of coming to you? The President of our country and of the ANC? It is abundantly clear that we are being punished for serving our country's best interests. Why? Why all this jealousy? Who Mr President are all those people involved in this issue? Are they so afraid of the truth that they have to steal, slander, fabricate massive untruths? What we have noticed is that these people somewhere along the line all link back to the remnants of the CCB as well as to the freemasons. Thus the question is Mr President when are they turning on you? They have already done so by creating traps into which you tend to step as even your so-called advisors are blinded in their lust for money and therefore fail to advise you accordingly.
